#### 1. Convening of the Annual General Meeting ("AGM")

There were 13 Full Members physically present at the AGM, 2 Full Members participated via video-conference, and 19 Full Members had appointed proxies to attend and vote. There were 47 Full Members as of the time of the AGM. A quorum of members prescribed by Article 33 of the Articles of Association (the "Articles") of the Association was present. CHAN Ching Man was appointed as the Chairman of the meeting and YIP Kim Ming was appointed as the secretary of the meeting. The Chairman called the meeting to order at 2:00 p.m.

#### 2. To adopt the agenda of the AGM 2022

A motion to adopt the agenda of the AGM 2022 was proposed by CHAN Kam Wa, seconded by WAI Siu Chung.

For: 35 votes; Against: 0 vote; Abstain: 1 vote;

Motion carried. The agenda of the AGM 2022 was adopted.

#### 3. To receive and adopt the minutes of the AGM 2021

A motion to adopt the minutes of the last AGM was proposed by CHAN Kam Wa, seconded by FUNG Sai Fu.

For: 35 votes; Against: 0 vote; Abstain: 1 vote;

Motion carried. The minutes of the AGM 2021 was received and adopted.

#### 4. To receive the Annual Report 2021-2022

A motion to receive the Annual Report 2021-2022 was proposed by TAM King Man Judy, seconded by YIP Choi Fung Koala.

Jason Lam, President of the Executive Committee, presented the Annual Report at the meeting. The Annual Report was delivered to new awardees by post in mid-March 2022 and was uploaded to the Association's website in mid-April 2022.

For: 35 votes; Against: 0 vote; Abstain: 1 vote;

Motion carried. The Annual Report was received and adopted.

#### 5. To receive and adopt the Financial Report for the year 2020-2021

A motion to receive and adopt the Financial Report for the year 2020-2021 was proposed by TAM King Man Judy, seconded by YIP Choi Fung Koala.

For: 34 votes; Against: 0 vote; Abstain: 2 votes;

Motion carried. The Financial Report for the year 2020-2021 was received and adopted.

#### 6. To receive the Auditors' Report for the Association Year 2019-2020

A motion to re-appoint Kingston C.P.A. Limited as the Honorary Auditor of the Association was proposed by TSE Wing Ning, seconded by CHAN Wing Chau.

For: 35 votes; Against: 0 vote; Abstain: 1 vote;

Motion carried. Kingston C.P.A. Limited was re-elected as the Honorary Auditor of the Association.

## 7. To approve the change of Articles of Association by means of special resolution

A motion to approve and adopt the draft Amended and Restated Articles as the new Articles of the Association was proposed by CHAN Chi Man, seconded by CHAN Wing Chau.

For: 34 votes (72.34%); Against: 0 vote; Abstain: 2 votes (4.26%);

As of the time of the AGM 2022, there were 47 valid Full Members, a list of which is attached as Appendix. Pursuant to section 88 of the Companies Ordinance (Cap. 622) and Article 1 of the Articles, a three-fourths majority of all members entitled to vote is required for passing a special resolution. Therefore, 34 votes are not adequate to pass this resolution.

Motion not carried.

#### 8. Closure of the meeting

There being no further business, the Chairman declared the meeting closed at 4:17 p.m.
